## Foreword

The group *Legal Documents in Ancient Societies* was established in 2008 to enhance collaboration among students of everyday documentation in the Ancient Near East, Ancient Egypt, the Greek and Hellenistic world, and the Roman State down to late Antiquity. A key means of achieving this goal is a series of annual meetings, focusing each on a different topic. The first meeting, held at the *American Academy in Rome* on 28.–30.9. 2008, focused on the study of different documentary applications of the letter from the third millennium BCE to late Antiquity. The twelve papers delivered in the meeting illustrated how letters were applied for similar purposes in different civilizations, sometimes millennia apart. Dominique Charpin, Ingo Kottsieper and James Sickinger, for example, demonstrated how royal state-apparatus applied letters for administrative purposes in the old Babylonian period, the Persian empire, and the Greek and Hellenistic world. Eva Cancik and Ingo Kottsieper discussed the application of letters in the administration of Justice in 13<sup>th</sup> century BCE Assyria and the Persian period. Sophie Démare-Lafont, Edward Harris and Éva Jakab showed how the application of letters promoted complex economic activities extending over different states and continents. The reader of this volume can study these cross cultural phenomena and will undoubtedly pinpoint others.

The papers delivered in Rome enabled the participants to pinpoint evolution of the position of the letter as a legal document in the Greek and Roman world. Letters began to be written in the Greek world in the archaic period, probably not long after the introduction of the Greek alphabet. But at first letters, and perhaps writing in general, were treated with suspect as a means to be employed by free states or their citizens for the documentation of their everyday activity. This fact was demonstrated by the papers of Paola Ceccarelli and James Sickinger. Besides, even if letters could be, and were certainly used on a regular basis for different purposes, early letters as discussed and cited by Edward Harris do not exhibit an established format that would indicate their independent use as a routine instrument for the documentation of everyday, particularly legal activities. Things changed in this respect in the Hellenistic period. Not only did letters become, as shown by James Sickinger, an established and acceptable means of issuing decrees by Hellenistic monarchs. The letter also became a routine type of legal document, recording legal acts whose performance was not attended by witnesses, and which gave rise to an obligation solely by virtue of the fact that the document was written by the prospective debtor in person. The result of this change, the *cheirographon*, was discussed in most papers focusing on the Hellenistic, Roman and Byzantine period.

Mark Depauw and Katrijn Vandorpe studied the evolution of the Demotic and Greek letter format as an established type of legal document in Persian and Ptolemaic Egypt. Sophie Kovarik studied the final triumph of the letter format, in the

Byzantine period, as *the* default means of documentation of legal activity. Andrea Jördens showed how the *cheirographon*—originally written by just one of the parties and therefore recording his obligations, but not those of the addressee of the document—was transformed, on occasions, into a “normal” legal document, recording obligations of both parties alike. Finally, Eva Jakab studied the reception of the *cheirographon* into Roman legal practice and theory. This last issue was also taken up by Johannes Platschek, whose paper focused on the procedural implications of contracts that were entered upon informally and were occasionally given evidence of in letters, as opposed to those entered upon by formal acts created within *ius civile*.

Sources quoted in this volume are abbreviated according to the conventions in each field of research. Ancient near eastern sources are abbreviated by S. Démare-Lafont and E. Cancik-Kirschbaum according to the conventions given in R. Borger, *Handbuch der Keilschriftliteratur, 3 vol.*, Berlin, 1967–1975, while D. Charpin’s article follows those of the *Archives Babylonniennes, XX<sup>e</sup>–XVII<sup>e</sup> Siècles av. J.-C.* ([www.archibab.fr](http://www.archibab.fr)). Classical literary sources, if abbreviated, are abbreviated according to routine conventions that can be found, for example, at <http://iam.classics.unc.edu/main/help/P.html>. Greek inscriptions are cited according to the conventions of the *Supplementum Epigraphicum Graecum* (SEG), and are also available at <http://dge.cchs.csic.es/lst/2lst3.htm>. Greek and Demotic papyri are cited according to the conventions of the *Checklist of Editions of Greek, Latin, Demotic and Coptic Papyri, Ostraca and Tablets* ([http://scriptorium.lib.duke.edu/papyrus/texts/clist\\_papyri.html#c](http://scriptorium.lib.duke.edu/papyrus/texts/clist_papyri.html#c)). Aramaic texts discussed by I. Kottsieper are cited according to the conventions established by Porten-Yardeni 1986–1999.
